

Tetron Software License Agreement

This Software License Agreement ("Agreement") is made between:

Licensor: Tetron Limited, a company registered in England and Wales with company number 07749907, and having its principal office at Tetron Limited, Kemp House, 160 City Road, London, United Kingdom, EC1V 2NX ("Licensor").

Licensee: The individual or entity using the software ("Licensee").

Effective Date: 15/12/2024

1. Definitions

- **Software:** The software product provided by Licensor, including any updates, modifications, or enhancements, but excluding any third-party software.
- **Development and Testing:** Use of the Software strictly for non-production purposes, including development, evaluation, and internal testing.
- **Production Use:** Deployment of the Software for any live or operational environment beyond development or testing purposes.
- **Commercial License:** A license granted by Licensor for the use of the Software in production environments, subject to separate terms and conditions.
- **Source Available:** The source code of the Software is made available for access, review, and modification by Licensees, subject to the terms and conditions of this Agreement. Such access does not confer any rights to use the Software in production, commercial environments, or for any purposes beyond those explicitly permitted herein. The Software's source code may not be redistributed, sublicensed, or otherwise exploited in ways not expressly authorized by the Licensor.

2. License Grant

2.1. Development and Testing License:

Licensor grants Licensee a non-exclusive, non-transferable, royalty-free, revocable licence to use the Software solely for development, testing, and evaluation purposes. No fees are due for such use.

The Software is provided under a Source-Available model, which grants access to its source code for the purposes outlined in this Agreement but does not permit production use, commercial deployment, or redistribution unless explicitly authorized by the Licensor under separate terms.

2.2. Commercial License:

For Production Use, Licensee must obtain a commercial licence when the Software is officially released for such purposes. The terms of the commercial licence will be provided at the time of release.

3. Restrictions

- Licensee shall not:
 - Use the Software for any production purposes without a valid commercial licence.

- Modify, reverse-engineer, or decompile the Software, except as permitted by applicable law.
- Distribute, sublicense, or make the Software available to third parties without prior written consent from Licensor.

4. Ownership

Licensor retains all rights, title, and interest in and to the Software, including but not limited to any and all intellectual property rights. No ownership rights are transferred to Licensee.

5. Confidentiality

Licensee agrees to keep the Software and related documentation confidential and not disclose it to any third parties without Licensor's prior written consent.

6. Warranties and Disclaimers

6.1. No Warranty:

The Software is provided "as is," without any warranty of any kind, whether express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, and non-infringement, to the fullest extent permitted by English law.

6.2. Limitation of Liability:

To the maximum extent permitted by English law, Licensor shall not be liable for any indirect, incidental, special, or consequential damages arising from the use or inability to use the Software, including loss of profits, data, or business.

7. Termination

7.1. Termination by Licensee:

Licensee may terminate this Agreement at any time by ceasing all use of the Software and destroying all copies in Licensee's possession.

7.2. Termination by Licensor:

Licensor may terminate this Agreement at any time if Licensee breaches any terms of this Agreement.

7.3. Effect of Termination:

Upon termination, Licensee shall cease all use of the Software and destroy all copies.

8. General Provisions

- **Governing Law:** This Agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the laws of England and Wales.
- **Jurisdiction:** The courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this Agreement.
- **Entire Agreement:** This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, understandings, or arrangements.

- **Amendments:** This Agreement may only be amended in writing and signed by both parties.
- **Severability:** If any provision of this Agreement is found by a court of competent jurisdiction to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.
